For many colleges and universities, 2008-09 will go down as tumultuous and painful. I am pleased to report that at Linfield, we managed to maintain steady progress. It may have been a tad anticlimactic, in fact, as this was our 151st year – the year after the sesquicentennial celebration. But the real message is this: Linfield remains solid and strong, and we continue to provide a first-class, personalized education to our students. We continue to maintain balanced budgets, and we are grateful to everyone who has supported the college.

Last year marked our 10-year reaccreditation by the Northwest Association of Colleges and Universities. After two years of preparation by Linfield faculty, staff, and trustees, the reaccreditation committee visited the college in fall 2008; at the beginning of the new year, we were granted reaccreditation. Although this was never in doubt, the process engaged most members of the Linfield community, who devoted hundreds (perhaps thousands) of hours to reports and planning. We learned a lot about ourselves, and we are improving as a result.

Last year we presented the President's Report electronically for the first time. The reaction of the Linfield community was overwhelmingly positive, and thus we present the report online once again. ### Academic Achievements in 2008-09

#### Introduction

The reaccreditation of Linfield College and the commendation of the learning outcomes articulated for the Linfield Curriculum are without question our most important achievements for this year. Linfield students have distinguished themselves as scholars, artists, scientists, and debaters, with over 20 students presenting their work at regional and national conferences, often as co-presenters with our faculty. Our faculty have been impressively productive as scholars, with significant publications, exhibitions, performances and presentations recognized in every division of the college. Even more importantly, our faculty were identified as outstanding scholar/teachers of their disciplines, with six faculty securing regional or national awards from organizations such as the Fulbright Foundation, the Freeman Foundation and the National Endowment for the Humanities.

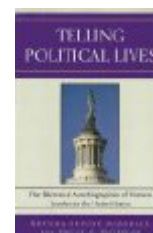

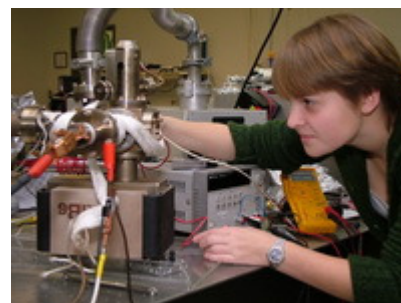


## President's Report

### Enrollment in 2008-09

#### Introduction

The 2008-09 year proved to be another very good year for enrollment at Linfield College. For the ninth time in the past 10 years, over 2,500 students attended Linfield at the McMinnville Campus, Portland Campus, or through the Adult Degree Program. The year was highlighted with the third largest headcount enrollment in McMinnville, a stable number of students enrolling in the Linfield-Good Samaritan School of Nursing in Portland, and a 5 percent increase in the number of credits taken through the Adult Degree Program. Of special note, the Linfield-Good Samaritan School of Nursing has more than doubled the number of nursing graduates each year compared to the 2000 graduating class, successfully contributing to the region's need for more nursing graduates.

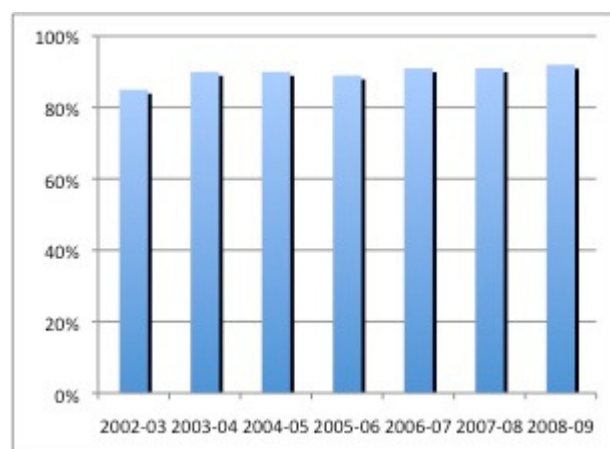

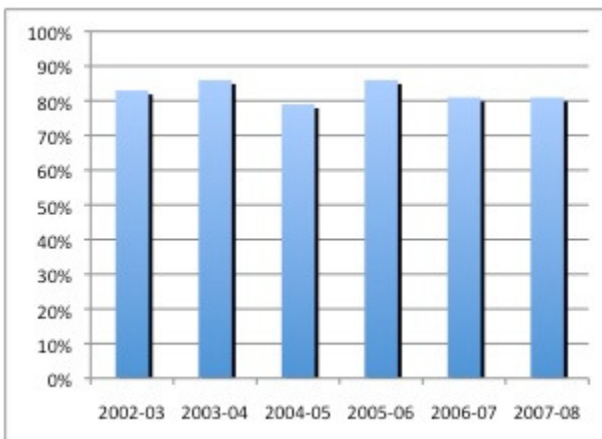

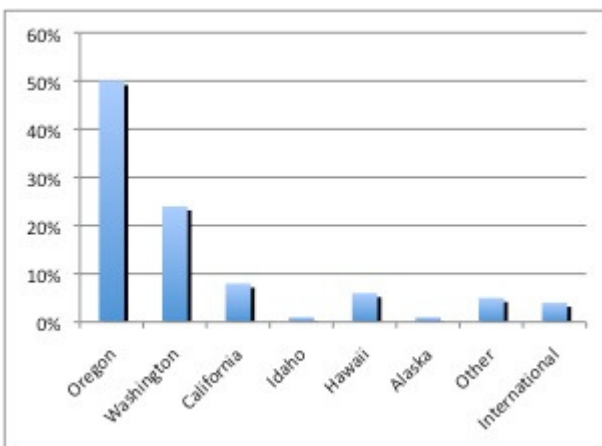

### Finances in 2008-09

#### Introduction

On June 30, 2009, for the 35th year in a row, Linfield College completed the fiscal year with a balanced budget. Through careful stewardship of revenue from tuition and fees, room and board charges, annual gifts, endowment earnings, and the use of campus facilities for summer camps and conferences, we are able to offer an outstanding education at a competitive price. In spite of significant national economic challenges, Linfield College remains financially very healthy. The financial reports below are based on preliminary unaudited figures.

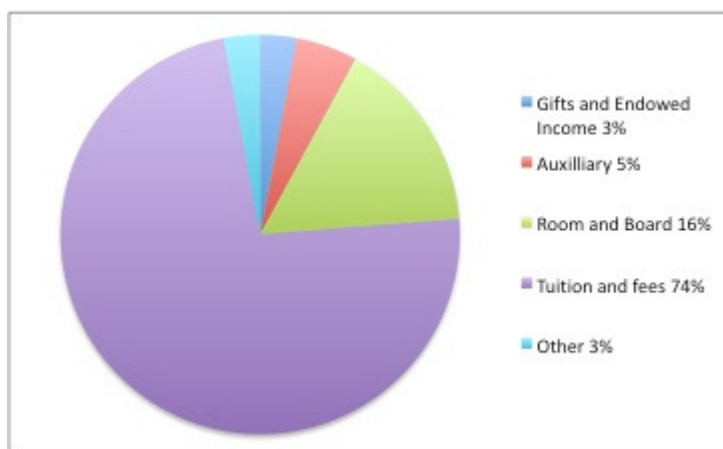

(unaudited; audited figures available in November)      \$51.1 million

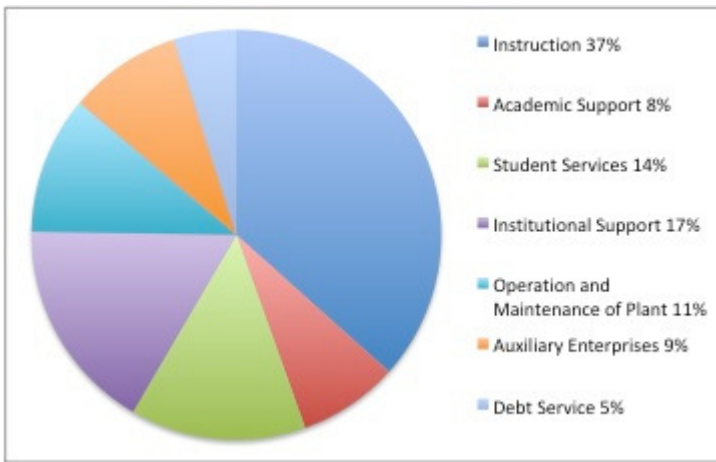
#### 2008-09 Sources of Revenue (preliminary)

## President's Report

### Philanthropy in 2008-09

#### Introduction

Linfield alumni, parents and friends, along with corporations and foundations, contributed more than \$4.5 million to the college in fiscal year 2008-09. This was achieved in spite of the recession and a nationwide drop in charitable donations. Of particular note is the large number of gifts dedicated to scholarship support for students. Affordability and access to a high quality independent college education experience are core values at Linfield, and the contributions of alumni and friends supported students whose families were most affected by the recession. After the State of Oregon reduced aid awards under the Oregon Opportunity Grant, Linfield donors made gifts that helped more than 400 students stay in college. Additional gift and grant support was received for the renovation of Northup Hall, for support of faculty development and academic program initiatives, for Wildcat athletics and for the library. Estate gifts played a crucial role in increasing Linfield's endowment for long-term financial strength. As always, unrestricted gifts through the Linfield Fund for Excellence helped support every student's Linfield experience.
