Ayala brings smiles to children worldwide

Seventeen-year-old Ruben Ayala '96 had no idea his life was about to change when he volunteered as a student translator with Operation Smile in his hometown of David, Panama. He arrived at the regional hospital to find 300 children with facial deformities hoping to see a visiting doctor.

"I had never seen a child with a cleft, never, so it was a huge shock," said Ayala, who left that day with a passion for Operation Smile and eventually went to work for the charity in 1996. "Now, when I see a child who is able to smile for the first time, and see the gratitude of the parents, I realize how lucky I am to do this work."

Since its founding in 1982, Operation Smile has organized international teams of physicians who have volunteered their time to perform surgeries on more than 150,000 children and young adults worldwide suffering from facial deformities such as cleft lips and cleft palates. Last year, they operated on more than 16,000 children in more than 30 countries.

Based in Norfolk, Va., Ayala leads a team of physicians, along with seven medical officers located in regions around the world, organizing supplies and personnel for the medical missions. His challenge is to account for everything that will be needed to operate in a developing country. On a typical day Ayala may begin his morning with a call to Bangladesh, then dial India and later in the day, Colombia.

"Tonight when I'm home, I'll be talking to China," said Ayala. "It's a hectic life, but one I love."

Even as a Linfield student, Ayala helped organize fundraisers to benefit the organization. He also played soccer and served as president of the Latin American club.

"I wanted to come to a small school with good academic programs and the opportunity to know my

professors," said Ayala, who went on to earn a medical degree and visits his family in Panama regularly.

He appreciated his small classes – he was one of six students in his molecular biology class – and credits Linfield for equipping him to deal with the cultural challenges he encounters in his work.

"Many times I've wondered how a kid from a developing country was given the chance that I have been given," he says. "I had the opportunity to learn, grow, explore, dream, serve. And for that I am grateful."
