#### Research Committee Report (Attachments)

- AFRI (USDA's Agriculture and Food Research Initiative) research project proposal
  - There was discussion about the AFRI Project Topic Summary.
  - The Research Committee recommends that the Board endorse the AFRI project topic and rationale, and that they be submitted for consideration when called for in 2017 by AFRI.
  - There was additional discussion about how/why the rationale is specific to Oregon.

Jones moved that the Board approve the AFRI Project Topic Summary as presented, which would authorize the Research Committee Chair to submit to AFRI for acceptance. (If accepted by AFRI the OWB would deposit \$150,000 in an escrow account as required to move forward in the process). Valot seconded and the motion carried unanimously.

- **ACTION: Pratt will submit the project topic summary and rationale to AFRI once they announce a date.**

### **MATTERS FOR DISCUSSION**

#### Marketing Committee Report (Attachment)

- Full Glass Research/Wine Opinions topline report
  - Willey reviewed preliminary summary data from the HFHE (High Frequency High End) consumer research that was conducted in November.
  - **ACTION: Willey will provide a final analysis to the Board once it's available and the industry will be informed about the data in an upcoming webinar during which the findings will be reviewed in detail.**

#### OWSCR Committee Report

- Sub-Committee on business and economics research
  - Owners and/or key decision-makers participated in focus groups held by OWRI in five growing region within the state between August and November.
  - In a recent meeting, the sub-committee considered researchable topics that would yield actionable results in a short amount of time.
  - The sub-committee also discussed financing of an eventual project.
    - OWRI has approximately \$75,000 available for business and economics research through OSU's applied economics department.
    - OWB has dedicated \$40,000 in the current fiscal year for "market research" which may also be a possible funding stream.
    - There is approximately \$400,000 remaining in OWRI's launch funding from the industry that could be tapped as well.

- Recommendation of the sub-committee is to fund research that focuses on DTC sales and driving consumer demand through wine clubs, etc.
- **ACTION: Danowski will provide a thorough analysis of focus group findings to the Board once it's available from James Sterns at OSU.**
